NOTE: The Commission's account for bank transfers is HSBC Sort Code 40-25-34 Account Number 52474700 (Provide the society name as reference). Any cheques should be made payable to the JERSEY GAMBLING COMMISSION.

- 2. Promoter Name and Residential Address: The Promoter is the term used by the JGC to describe the person from within the charity or club who has been nominated to run the gambling event. The reason the JGC requires the home address is because all contact is made directly with the Promoter and the Registration Certificate will be sent directly to their home address. This individual (the Promoter) is asked to give an undertaking to conduct the gambling events in accordance with the Gambling (Charitable and Membership Gambling Services) (Jersey) Regulations 2012. They must read and follow the guidelines provided within the Policy Statement for Social and Charitable Gambling, Code of Practice for Social and Charitable Gambling, Advice Note for Conducting Lotteries and the Policy Statement for Advertising Commercial or Charitable Gambling.
- 3. Total Value of Prizes: List the value of prizes for each event. This should be the total amount spent on purchasing prizes combined with the perceived retail value of any donated prizes. All prizes should be in the possession of the club or charity prior to the commencement of the sale of tickets. The Promoter must ensure that those purchasing tickets for an event are fully aware of what the prizes are and that the winner will receive any prize won. The Promoter should not be dependent on sale of tickets to cover the cost of prizes.
- 4. Venues: Please provide the venue where the gambling event (sale of tickets and/or draw) will take place. If tickets are to be sold at an event and the draw will take place at the same event, provide the name of the venue where this will happen. If tickets are being sold online and drawn at an event, list the venue for the draw and provide details of how the tickets are being sold separately. All draws should ideally be witnessed by the public or an independent witness.
- 5. Please refer to the Advice Note for Conducting Lotteries for guidance on such matters as what information should be included on a lottery ticket, selling tickets, conducting a draw, and distributing prizes to winners. You must ensure no tickets are sold to minors (under 18). If you are running a 100 club, please refer to the 100 clubs section of the Advice Note and enclose a copy of the club's Terms and Conditions with this completed Application Form, and advise us how these Terms & Conditions are made available to potential members.
- 6. If any details set out on this Application form change prior to the determination of this Application, you must notify the Jersey Gambling Commission in writing as soon as reasonably practicable.

Please note that the Rehabilitation of Offenders (Exceptions) (Jersey) Regulations 2002 applies and that all convictions must therefore be declared. All details may be checked via the Police. In case that there is a conviction, the applicant/promoter must declare it in writing to the Jersey Gambling Commission. , declare that I have not been convicted of any of the offences other than those declared. I further declare that I will inform the Jersey Gambling Commission immediately should any information come into my possession that materially impacts upon this declaration.
